ANNOUNCEMENT: - Horsforth & DMC Ltd will organise an Restricted trial held under the National Sporting Code, The Trials Standing Regulations of the ACU, the following Supplementary Regulations and any final instructions that may be issued for the meeting.

ELIGIBILITY: - Restricted to registered youth members of clubs affiliated to the ACU in classes below. Participants must hold a current ACU Trials Registration Card or a SACU licence. Other riders must produce a licence and Start Permission confirming Insurance from their FMN. (Registrations will be checked at signing on).

MACHINES: - Motorcycles as per NSC Appendix D Category 1, Group A1 solos and TSR 8.

CLASSES: - Main Classes for Oset Northern Cup: Youth D and E Class with 4 Routes Elite, Hard, Intermediate and Beginners. Other Youth Classes will be able to ride on a fun / no award basis.

START / VENUE: -11.00 a.m. at Swaine Woods Broadway Horsforth Leeds LS18 4RP. There will be no refreshments, petrol or toilets at the start.

AWARDS: - 1st, 2nd and 3rd in class on each Route; an Award
All other support classes are on a non award basis.
NO RIDER TO WIN MORE THAN ONE AWARD.
The Oset Northern Cup Series will consist of four rounds. Points will be awarded to riders of Oset machines in D and E classes on each route, as per the ACU Youth Championship scoring system. The riders amassing the most points in each route/class will be the winners of the series award. Points are not transferable between Routes and or Classes.

COURSE: - All sections are on Private Land (which must not be revisited). Course will consist of 3 laps of 6 or 8 sections. To be announced on the day.

METHOD of MARKING: - As per TSR 22a; stop permitted. Ties will be resolved as per TSR 23.

PROTESTS: - as per the National Sporting Code of the ACU section 10.04.

ACU REGISTRATION: *Please note that all participants are required to hold an AC Trials Registration/ Membership Card or SACU Licence. See Eligibility above.*

GENERAL: - Please take your litter home. Dogs to be kept on a lead at all times & cleaned up after.
Do not park obstructing the footpath. No riding of machines outside the woods.

When arriving / leaving the venue do not turn right across carriageway, only approach downhill from Horsforth and leave downhill towards Rodley!

- ENTRY DECLARATION: I the undersigned apply to enter the event described above and in consideration thereof: -
I hereby declare that I have had the opportunity to read, and that I understand the National Sporting Code of the ACU, the ACU Standing Regulations, such Supplementary Regulations as have or may be issued for the event, and agree to be bound by them.
I further declare that I am physically and mentally fit to take part in the event and I am competent to do so. I confirm that the machine(s) as described below which I shall participate on shall be suitable and proper for the purpose. I confirm that I am eligible to compete on the machines for which I have entered.
I confirm that if any part of the event takes place on a public highway, the machine(s) described below shall be insured as required by the Road Traffic Acts, or equivalent legislation, and that they will comply with the regulations in respect thereof.
I accept responsibility for any items borrowed from the Organiser during the course of the event. These items include but are not restricted to (safety clothing, transponders, and accessories). I understand that I am liable for the cost or replacement of any items lost or not returned and non-payment or non-replacement of items borrowed may affect my entry into subsequent events.
I confirm that I have not been refused an ACU Licence, nor had an ACU Licence suspended, nor have I been excluded from any ACU competition.

ACKNOWLEDGEMENT OF THE RISKS OF MOTORSPORT: I understand that by taking part in this event I am exposed to a risk of death, becoming permanently disabled or suffering some other serious injury and I acknowledge that even in the event that negligence on the part of the ACU, any event organiser, any circuit owner, the promoter, the organising club, the venue owner, or any individual carrying out duties on their behalf were to be a contributory cause of any serious injury I may suffer, the dominant cause of any serious injury will always be my voluntary decision to take part in a high risk activity.
