- ANNOUNCEMENT:** West Leeds Motor Club will organise a Centre Restricted Trial on 29th July 2018 for solo motorcycles, run under the National Sporting Code, Standing Regulations of the ACU, the Yorkshire Centre Rules current at the time, the following Supplementary Regulations and any final instructions issued for the meeting.
This event will be the 2018 Yorkshire Centre Team Trial and a round of the youth A B C Championship
- ELIGIBILITY:** Restricted to registered members of clubs affiliated to Yorkshire Centre ACU. All riders and passengers must hold a current ACU / SACU Trials Registration card or ACU/SACU competition licence. Any rider or passenger from another FMN MUST produce a licence issued by their FMN together with start permission and proof of personal accident insurance.
- MACHINES** Motorcycles as per NSC Appendix D Category 1, Group A1 Solos; and TSR 8.
- CLASSES:** **Championship Route, Clubman Route A, Clubman Route B**
Teams:- Consisting of 3 riders. These may be riders of any grade but the team status will be determined by the highest graded rider.
- Youth A B C may ride on an individual basis and be eligible for points towards the Centre Championship. To gain points A class must ride the Championship course, B class the Clubman Route A and C class Clubman Route B.**

The onus on finding the sections is that of the competitor, the route will be clearly marked and should be closely followed. Dual sections will be used to accommodate Clubman and B and C class youth riders.
- METHOD of MARKING:** TSR 22b. No-stop. Ties will be resolved as per TSR 23
